## The Challenge of Offline Alternative Investments Data



In short, documentation for offline alts is stored in a variety of source locations, in analog formats (usually PDFs), and the embedded data is "unstructured" (has no common format). This scenario creates enormous processing complications and renders the data virtually unusable for reporting purposes.

#### The Solution

So how is iCapital solving this challenge? As the alts data landscape is evolving quickly, the firm's 1-2 punch involves the deployment of its fast-growing DLT platform, combined with its leading technology-enabled Alts Data Management solution.
