Designed to serve as your primary source for navigating the world of alternative investments.

We continue to see tremendous growth in alternative investments. Assets under management (AUM) nearly doubled in the last five years from \$8.9 trillion in 2018 to \$16.2 trillion today.¹

We attribute that to three factors:

- 1) Financial advisors are seeking new sources of return, income, and diversification given traditional 60/40 portfolios have been tested through market volatility and rising correlations; and the private markets have historically delivered better performance.²
- 2) There is broader awareness of alternative investments and more high-quality education available leading to a greater understanding of the asset class.
- 3) The alternatives industry is focused on improving the processes and technology and offering innovative products such as open-ended (semi-liquid) funds.

While individual investors have historically been underrepresented in this asset class, we believe alternatives have evolved from a "nice to have" to an essential component in portfolios.
